Invitation to Apply for Eligibility and to Bid for The Supply, Delivery, Installation, Testing & Commissioning of 20MVA Power Transformer at Pamplona Substation, Sitio Lunad, Poblacion, Pamplona, Camarines Sur

1. The **CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I)**, through a **LOAN** from the **NATIONAL ELECTRIFICATION ADMINISTRATION (NEA)** intends to apply the sum of **Thirty-Three Million Eight Hundred Two Thousand Pesos (Php 33,802,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **The Supply, Delivery, Installation, Testing & Commissioning of 20MVA Power Transformer at Pamplona Substation, Sitio Lunad, Poblacion, Pamplona Camarines Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. CASURECO I now invites bids for The Supply, Delivery, Installation, Testing & Commissioning of 20MVA Power Transformer for Pamplona Substation, Sitio Lunad, Poblacion, Pamplona Camarines Sur. Completion of the Works is required **One Hundred Eighty Days (180 Days)**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a Philippine Contractors Accreditation Board (PCAB) License Category of at least "B" and at least a Size Range of Medium A. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified on the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives (IRR of RA 10531).
4. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from May 1, 2025 to May 20, 2025 from Monday to Friday during office hours 8:00 A.M. to 5:00 P.M. (except Saturdays, Sundays and Holidays), and on May 21, 2025 from 8:00 A.M. to 12:00 P.M.
6. A complete set of Bidding Documents may be acquired by interested bidders from the address below and upon payment of a non - refundable fee for the Bidding Documents in the amount of **Twenty-Five Thousand Pesos (Php 25,000.00)**.
7. CASURECO 1 will hold the face to face Pre-Bid Conference on **May 8, 2025 9:00 AM** and the Opening of Bid is on **May 21, 2025 1:30 PM** at Rm. 303 Hall of P's, CASURECO 1 Main Office, which will be opened only to all interested parties who have purchased bidding documents and Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
