Interested bidders must bring a Certified True Copy of the following government licenses and permits such as:


1. DTI Business Name or SEC Registration Certificate or CDA Registration Certification;

### **A. FIRST ENVELOPE (TECHNICAL COMPONENT)**

1. The Terms of Reference and the Instructions to Bidders as initialed by the bidder;
2. An affidavit in the form attached hereto as stating that the bidder has conducted an ocular inspection of the Two (2) units Unserviceable 5MVA Power transformer and has considered all pertinent documents relative thereto and has been accorded full and reasonable information thereon as to enable the bidder to submit a responsible bid;
3. DTI Business Name or SEC Registration Certificate or CDA Registration Certification;
4. BIR Registration Certification which contains the Tax Payer's Identification Number (TIN);
5. Tax Clearance from BIR as proof of full and prompt tax payments;
6. Latest Income Tax Return;
7. Current & Valid Mayor's/Business Permit, if expired, a copy of the expired Mayor's Permit and the Official Receipt as proof that the bidder has applied for renewal of the permit issued by the city or municipality where the principal place of business of the prospective bidder is located;
8. A valid DENR-EMB issued Treatment, Storage and Disposal Facilities (TSD) Registration Certificate with Category D & F valid until the released of Permit to Transport Certificate;
9. A valid DENR-EMB issued House Waste (HW) Transporter Registration Certificate, registration that can transport HW No. I101, used industrial oil including sludge. valid until the released of Permit to Transport Certificate.
