INVITATION TO BID FOR THE RE-BIDDING OF THE SUPPLY OF TWO (2) BRAND NEW 8 TONNER BOOM TRUCK WITH AUGER AND SIDE MOUNTED BASKET AND TOP CONTROL ROTATING WITH BOOM MOUNTED ON 4X2 6-WHEELER TRUCK

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC.(CASURECO I), through CASURECO I's BUFFER FUND intends to apply the total sum of **Twenty-four Million Pesos only (24,000,000.00) inclusive of all applicable taxes and charges (VAT, delivery cost, testing, inspection, commissioning)** being the **Approved Budget for the Contract (ABC)** under board resolution No. 08, Series of 2026 to payments under the contract for RE-BIDDING OF THE SUPPLY OF TWO (2) BRAND NEW 8 TONNER BOOM TRUCK WITH AUGER AND SIDE MOUNTED BASKET AND TOP CONTROL ROTATING WITH BOOM MOUNTED ON 4X2 6-WHEELER TRUCK. Bids received in excess of the ABC shall be automatically rejected at bid opening
2. CASURECO I now invite bids for The Supply of Two (2) Brand New 8 Tonner Boom Truck with Auger and Side Mounted Basket and Top Control Rotating with Boom Mounted on 4X2 6-Wheeler Truck.
3. Delivery period is **within 180 calendar days from the receipt of the Notice to Proceed (NTP)**. Bidders should have completed within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Republic Act (RA) 9184 and its revised IRR known as the "Government Procurement Reform Act" and Republic Act (RA) 10531 NEA Procurement Guidelines.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. Interested bidders may obtain further information from **CASURECO I** and inspect the Bidding Documents at the address given below from **January 15, 2026 to February 2, 2026** from **Monday to Friday during office hours 8:00 a.m. to 5:00 p.m. (except Saturdays, Sundays and Holidays)**, and on **February 3, 2026 from 9:00a.m. to 12:00p.m.**

However, only Bidders who have paid the non-refundable fee for the bidding documents can participate in the bidding.
8. **CASURECO I** will hold a **Pre-Bid Conference on 9:00 a.m., January 22, 2026** at Training Room, Rm-205 CASURECO 1 Main Office, Puro-Batia, Libmanan Camarines Sur, which shall be open only to all interested parties who have purchased the Bidding Documents.
9. Bids must be **delivered to the address below on or before 1:00 p.m., February 3, 2026**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.
10. **Bid opening shall be on 1:30 p.m., February 3, 2026** at the Training Room, Rm-205 CASURECO 1 Main Office, Puro-Batia, Libmanan Camarines Sur. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. All activities related to the bidding process will be conducted at the CAMARINES SUR I ELECTRIC COOPERATIVE, INC. Headquarters, Puro Batia, Libmanan, Camarines Sur.
