



INVITATION TO BID FOR THE SUPPLY OF LABOR AND MATERIALS FOR CONSTRUCTIONS OF DISTRIBUTION LINE EXTENSION FOR TWENTY-TWO (22) SITIOS IN THE MUNICIPALITIES OF CAMALIGAN, LIBMANAN, LUPI, PAMPLONA, PASACAO, RAGAY, SAN FERNANDO AND SIPOCOT, CAMARINES SUR.

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I), through the **2011-2023 Subsidy Savings Sitio Electrification Program (SEP) Subsidy under the National Electrification Administration's (NEA) SEP Subsidy** intends to apply the sum of **Fifty Eight Million Nine Hundred Eighty Three Thousand One Hundred Thirty Four and Twenty Centavos (Php. 58,983,134.20)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for Extension of Distribution Line for Twenty-Two (22) Sitios in the Municipalities of Camaligan, Libmanan, Lupi, Pamplona, Pasacao, Ragay, San Fernando and Sipocot, Camarines Sur with ITB No. CAS1-2025 SS 22S. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders must have a Philippines Government Electronic Procurement System (PhilGEPS) Registration with a Platinum Membership and Philippine Contractors Accreditation Board (PCAB) License Category B. 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations 2016 (Revised IRR 2016) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

9. Bids must be delivered to the address below on or before February 19, 2026 at 8:30 am. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Clause 18.
10. Bid Opening shall be at 9:00 am, February 19, 2026. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. All activities related to the bidding process will be conducted at the CAMARINES SUR I ELECTRIC COOPERATIVE, INC. Headquarters, Puro Batia, Libmanan, Camarines Sur.
