## INVITATION TO BID FOR THE PROCUREMENT OF HEALTHCARE SERVICES FOR CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I)

1. The Camarines Sur I Electric Cooperative, Inc. (CASURECO I), through its **General Fund** intends to apply the total sum of **Two Million Two Hundred Ninety Thousand Pesos (Php 2,290,000.00)** being the **Approved Budget for the Contract (ABC)** for the **Procurement of Healthcare Services for CASURECO 1 /ITB#CAS1-2026-HMO**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidders should have completed a contract similar to the Project at least One (1) year within the last five (5) years prior to the bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly on Item 3, Page 5, Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Memorandum No. 2017 – 019 Revised Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-R.A. 10531 (2017).
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
