INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY AND DELIVERY OF KWHR METERS (LOT-I), SINGLE-PHASE RECLOSERS (LOT-II), WIRES AND CONDUCTORS (LOT-III), AND VARIOUS LINE HARDWARE MATERIALS (LOT-IV) FOR CASURECO 1 BUFFER STOCKS.

1. The **CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO 1)**, through its **BUFFER FUND** intends to apply the total sum of **NINETEEN MILLION FOUR HUNDRED NINETY THOUSAND AND THREE HUNDRED FIFTY PESOS (PHP19,490,350.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for THE SUPPLY AND DELIVERY OF KWHR METERS (LOT-I), SINGLE-PHASE RECLOSERS (LOT-II), WIRES AND CONDUCTORS (LOT-III), AND VARIOUS LINE HARDWARE MATERIALS (LOT-IV) FOR CASURECO 1 BUFFER STOCKS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
