INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY AND DELIVERY OF SINGLE-PHASE RECLOSERS (LOT-II) FOR CASURECO I BUFFER STOCKS 2026

1. The **CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO 1)**, through its **BUFFER FUND** intends to apply the total sum of **FOUR MILLION THREE HUNDRED TWENTY THOUSAND PESOS (PHP4,320,000.00)** being the **Approved Budget for the Contract (ABC)** to payment under the contract for THE SUPPLY AND DELIVERY OF SINGLE-PHASE RECLOSERS (LOT-II) FOR CASURECO I BUFFER STOCKS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. CASURECO 1 now invites bids for Supply and Delivery for Lot-II.

3. Delivery of the Goods is required within **Sixty (60) Calendar Days** upon receipt of Notice to Proceed. Bidders should have completed within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified on the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives (IRR of RA 10531).

Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from **September 3, 2026 to September 21, 2026** from Monday to Friday during office hours **8:00 A.M. to 5:00 P.M.** (except Saturdays, Sundays and Holidays), and on **September 22, 2026 until 8:00 A.M.**
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php5,000.00)**.

CASURECO 1 will hold the Pre-Bid Conference on **September 10, 2026 9:30 AM** and the Opening of Bid is on **September 22, 2026 9:30 A.M.** at the CASURECO 1 Training/Grit Room, Rm. 205 CASURECO 1 Main Office, which will be open only to all interested parties who have purchased bidding documents and Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
8. Bids must be delivered to the address below on or before **September 22, 2026 9:00 A.M.** Late bids shall not be accepted. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents for the Supply and Delivery of Single-Phase Reclosers (LOT-II) for CASURECO I Buffer Stocks.
